HARBOUR BUSINESS FORUM
CENTRAL BUSINESS DISTRICT TRANSPORT, LAND AND MARINE PLANNING

We write with respect to your planned meeting of November 22nd. We wish to clarify our present views on the Central development, explain our current work and focus on this area, and to request an opportunity to present these to your members in a brief presentation.

The Harbour Business Forum (HBF) came together earlier this year as a coalition of businesses and business groups all of whom have like-minded concerns about current and future plans for the development of the harbour and the harbour districts. A list of our current membership (including over 120 major companies and business associations) is attached.

HBF in particular is concerned about:

- The apparent lack of a long term vision for the design of Hong Kong's harbour and harbour-front districts;
- The lack of a consistent and transparent framework against which decisions are made concerning the harbour;
- A lack of willingness, on the part of Government, to engage with relevant parties to discuss amendments to existing plans where demand exists for change, and
- Ultimately the apparent lack of overall coordination across the 17 or so departments and bureaus of Government who have some form of involvement with the harbour and harbour-front development. Indeed, we are calling for the establishment of a single independent party to oversee the harbour from envisioning to operation.

By way of background, HBF has been in dialogue with senior members of the Administration for some months working behind the scenes to attempt to come to a meeting of minds on various harbour-related issues. Our concerns are less to do with "Design" but rather to do with "Process" and "Principles".

In response to a number of contacts at the higher levels of Government, Michael Suen and Rita Lau met with the Patrons of the HBF in early September and presented their plans for Central. At that meeting Rita Lau asked members of the HBF to respond to her with our concerns about Central as framed within the context of Harbour Planning Principles (Principles). These Principles had been issued by the Harbourfront Enhancement Committee and were subsequently (20 July 2005) endorsed by HBF. HBF has now prepared an initial response to Rita Lau's challenge and this will be distributed to her and to your panel committee shortly.

We acknowledge that the Principles, as currently written, remain open to varying degrees of interpretation. To this end, HBF is working within the HEC to further tighten the Principles by including rather more robust, measurable indicators of performance.



We have also written to Michael Suen and asked for a moratorium on all development above on and around the Central reclamation until such time as relevant canvassing of opinions have been sought as to the opportunities for amending the Government's current plans for such development.

HBF does not oppose the proposed development per se. Where we have concerns lie in the relevance of the decision-making processes used in arriving at Government's plans. In this regard we do not oppose the construction of a sunken by-pass for Central as long as reclamation in Wanchai is minimized and the harbour-front is enhanced.

I would draw your attention to two supporting pieces of evidence:

Town Planning Board – Press Release of 5 August 2005

"The extent of reclamation within WDII is being reviewed by the Government. It is premature to consider whether to amend that part of the OZP before completion of the review around mid 2006. The Board will look into the matter upon availability of the findings," the spokesman added.

"Nevertheless, the Board saw some merits in SPH's proposals for harbour-front planning. It agreed to request the Government to prepare/refine planning/design briefs for this important waterfront, in particular the groundscraper and the waterfront related commercial and leisure uses sites, to ensure that the future developments would blend in with the waterfront setting, facilitate pedestrian access to the waterfront, and promote visual permeability of the developments".

• Extract from "Submission to the Expert Panel" – presented by Transport Department on 3 September 2005.

"Traffic saturation in Central by 2016 is likely even with the building of the Central Wanchai Bypass."

We believe that plans and the design brief for Central, as currently presented by Government, will lead to significantly sub-optimal outcomes. Further, that haste in pushing through these plans will allow insufficient time for their essential review and amendment.

Professional research being funded by our membership has initially indicated that in terms of accessibility, vibrancy, distribution of density, public open space, visual access, urban connectivity and identity, the proposals will fail to meet the Principles , and will be far removed from the world-class gateway to which our community aspires. Please find attached an initial one-page outline of what this means from the business perspective.

As mentioned above, we would greatly appreciate the opportunity to present our views to your panel. Ms Michele Weldon, HBF's Coordinator, will follow up with your secretariat to facilitate the necessary arrangements.

We look forward to sharing our views.

HBF Review of Central Reclamation and Waterfront

based on Hong Kong Harbour Planning Principles
Harbour Business Forum

1. VIBRANT WATERFRONT

- waterfront definition to include spaces deep into the city
- human scale development on the waterfront
- · street-level open air dining and entertainment
- market developments on the park reduced to two storeys
- lining the waterfront address with dynamic uses dining, arts, culture, residential, marine, other commercial in addition to retail

2. PEDESTRIAN CHOICE

- · ability to walk on ground level in addition to bridges
- reduce roadway engineering and scope to provide pedestrian crossings
- · reduce bridges and decks across waterfront address
- protected pedestrian easements through development blocks allowing meandering
- allowance for multiple modes of transportation foot, bike, ferry, tram

3. PHYSICAL, VISUAL ACCESS AND OPENNESS

- high quality pedestrian links with direct sensory connection to the harbour
- permeability along waterfront address to promote pedestrian interaction and views
- protected views from existing users as economic resources
- · protected views of ridgeline and hills from waterfront

4. URBAN CONNECTIVITY AND IDENTITY

- areas along waterfront integrated to hinterland
- character and uses along corridors that reflect heritage and identity
- · development ensuring ceremonial public access along these corridors

5. WORLD CLASS GATEWAY PARK

- urban spatial definition to embrace the formal park
- waterfront address as a celebration of the gateway park, not a utility
- reinforce Central's role with uses and design befitting Hong Kong's international identity
