Past events

Kai Tak Development Review presentation

The [Harbour-Front Enhancement Committee](#)'s Sub-Committee on South East Kowloon Development Review presented the progress of the Kai Tak Development review to HBF members on the 18th July. The presentation was informative and a lively Q&A session was held afterwards. Key points made by HBF included:

- Holistic and integrated planning and for the assessment of all territorial needs, both on and around the harbour.
- Criteria, including economic, social, environmental, planning, transport, for determining what waterfront project are needed.
- A clear and transparent valuation process for these projects.
- Adoption of the Harbour Planning Principles by all levels of the government and the community.
- Due process and transparency to be observed in the consultation process

A letter was sent to Town Planning Board regarding the HKCEC extension planning application. In the letter HBF urged for a strategic review of the harbour, the Harbour Planning Principles be applied to all current and future development and that due process and transparency be observed for all projects.

Our Focus

Research

- An Audit of the harbour – Mapping of the HK Harbour Waterfront

The purpose of this is produce a set of maps that graphically depict the context of Victoria Harbour and lays out this context in a way that can be critically examined. The maps and the analysis report will be completed and published by the end of September.

- Study the value of the harbour - Community Value Study

We are undertaking a study of the value of Harbour-Front enhancement in other locales, and the potential environmental, social and economic value of Hong Kong's harbour and Harbour-Front. This study is due to be completed by December. Updates on the progress of the study will be made here.
